4. Approval to form and appoint members to a First Responders Technology and Cyber Security Data Center Advisory Committee

Have reached out to the following, Carl Kim, Executive Director National Disaster Preparedness Training Center, Luke Meyers, State Disaster Management Advisor, Office of Governor Josh Green, James Barros, Administrator Hawaii Emergency Management Agency, Doug Murdock, CIO Enterprise Technology Officer. The focus and discussion for their consideration is that the campus is still technology and innovation focus. It includes ideas of systems of alert warning systems for natural and man-made threats and hazards, satellites, arial, drone remote sensing, mapping integrated with machine vision

and learning, classification algorithm for threat assessment and prioritization of response and recovery capabilities.

Chair requests a motion to establish a FRTC Advisory Committee

Mr. Kim questions who the FRTC Advisory Committee will report to, if the Committee will disclose information to the public and if the Committee can explore how HTDC extricate from the project, if the land can be re-purposed and if the Committee can look into various options for the property.

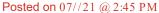

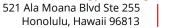

Motion made by Mr. Kimura / Second by Mr. Wicker

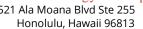
