## 4. Hawaii Small Business Capital (HI-Cap) Program – Approval of Investment in OMVC Hawaii Fund I LLC and Hawaii Defense Venture Fund I, LLC (Pacific Impact Zone)

Mr. Lam introduces Mr. La who will provide an overview of OMVC and Pacific Impact Zone.

Mr. La advises today will be two investment opportunities previously presented. This is for the HI-Cap program, a matching program, federally funded. The first is OMVC, global early stage investment fund, established in 2014 by co-founders Jason Best and Mark Munoz. Office locations in San Francisco, Honolulu, New York, Singapore, and Hong Kong with two existing funds and establishing a third Hawaii focused fund. Seeking to raise \$6 million fund of that \$3 million will be Hi-Cap.

The second investment is defense spectra fund managed by Pacific Impact Zone, a local Hawaii organization that works with government defense dual use factors. Looking to raise \$2 million defense venture fund of that \$500,000 from the HI-Cap program.

- A.
